## Postdoctoral Fellow in informatics

### About the project/work tasks:

### Qualifications and personal qualities:

- The applicants must hold a PhD in informatics or mathematics, or must have submitted his/her doctoral thesis for assessment prior to the application deadline. It is a condition of employment that the doctoral degree has been awarded.
- Knowledge and experience in informatics is required.
- Solid background in informatics and mathematics. Interest for research in one of the six research groups.
- Personal skills will be emphasized. The candidates must have a great capacity for work and enthusiasm for research.
- The applicants must be able to work independently and in a structured manner and demonstrate good collaborative skills.
- The applicants must be proficient in both written and oral English

### About the position of postdoctoral fellow

The position of postdoctoral fellow is a fixed-term appointment with the primary objective of qualifying the appointee for work in top academic positions. The fixed-term period for this position is 4 years, of which 25 per cent will be comprised of mandatory work, such as teaching and/or administrative tasks. Individuals may not be hired for more than one fixed-term period as a postdoctoral fellow at the same institution.

The applicants shall submit a project proposal for the qualifying work which shall comprise a description of the project and a progress plan outline. It is a requirement that the project is completed in the course of the period of employment.
