### About the position

[The Department of Accounting, Auditing and Law](#) invites applications for a position as Assistant Professor in Financial Accounting, starting in August 2019 or on a mutually agreed date.

We seek to fill the position with an early-career candidate with a focus on archival financial accounting research, and other research areas in accounting may also be considered. Applicants must have a Ph.D. in accounting or a related field from an accredited institution by the start date of the job. Applicants should have a strong commitment to research and teaching excellence and demonstrate the ability to publish in leading academic journals.

In addition to research, the position will involve teaching and supervision of master students. The duration of the contract is four years.

In the assessment of applicants, international experience and qualifications will be emphasised. In the event of equivalent qualifications, female applicants will be given preference.

The salary will be negotiable within the Norwegian State Salary Scale for Assistant Professors. External research grants and teaching in executive programs offer opportunities for supplementing this salary.
